7. New applications to vote by proxy at this election must reach the Electoral Registration Officer at Town Hall, Main Road, Romford, RM1 3BD by 5 pm on Wednesday, 4th December 2019.

Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Town Hall, Main Road, Romford, RM1 3BD by 5 pm on Thursday, 12th December 2019. The physical incapacity must have occurred after 5 pm on Wednesday, 4th December 2019. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5 pm on Wednesday, 4th December 2019.
