GUIDELINES FOR COMPLETING YOUR STREET NAMING AND NUMBERING APPLICATION:

1. ALL PLANS MUST BE SUBMITTED WITH YOUR APPLICATION CLEARLY MARKING UP ENTRANCES TO THE NEW PROPERTIES. LAYOUT PLANS MUST BE MARKED CLEARLY WITH ANY PLOT NUMBERS SO A PLOT TO POSTAL SCHEDULE CAN BE PROVIDED.
2. NO NEW STREET OR BUILDING NAMES CAN BEGIN WITH "THE"
3. THE BUILDING OR ROAD NAME SUFFIX MUST BE SUITABLE FOR THE TYPE OF BUILDING/ ROAD IT IS TO BE USED FOR. (FOR EXAMPLE: OAK CLOSE, SUFFIX IS CLOSE)
4. ALL NEW BUILDING AND ROADS NAMES ARE SUBJECT TO APPROVAL AND ALL NEW NAMING PREFIXES MUST BE UNIQUE. (FOR EXAMPLE OAK CLOSE, PREFIX IS OAK) WE RESERVE THE RIGHT TO HAVE THE FINAL SAY IN WHETHER A NAME IS ACCEPTABLE AND THERE IS NO APPEALS PROCESS.
5. IF A NEW BUILDING NAME IS ATTACHED TO AN EXISTING PROPERTY THAT ALREADY HAS A STREET NUMBER IN ANY EXISTING ROAD THE EXISTING NUMBERING MUST ALWAYS BE RETAINED WITHIN THE ADDRESS.
6. ROADS MUST BE NUMBERED (CONS) SEQUENTIALLY WITH NO OMISSIONS OF ANY NUMBERS; OR ODDS ON ONE SIDE AND EVENS ON THE OTHERS ALSO WITH NO OMISSIONS OF ANY NUMBERS.
7. FLATS MUST BE NUMBERED SEQUENTIALLY FROM THE BOTTOM UPWARDS IN A CLOCKWISE MANNER; WITH NO OMISSIONS OF ANY NUMBERS
8. PLEASE SPECIFY IF THE NEW PROPERTIES WILL HAVE THEIR OWN POSTAL DELIVERY POINTS OR LETTER BOXES OR WHETHER THE POST WILL BE DELIVERED TO A CENTRAL DELIVERY POINT.
9. WE DO NOT ISSUE POSTCODES TO NEW ADDRESSES THIS IS CARRIED OUT BY ROYAL MAIL. ANY NEW ADDRESSES ARRANGED THAT ARE UNDER CONSTRUCTION WILL BE ADDED TO ROYAL MAIL NOT YET BUILT FILE (NYB) UNTIL READY FOR OCCUPATION. THEY WILL THEN NEED TO BE TRANSFERRED BY YOU ONTO THEIR LIVE POSTAL ADDRESS FILE. THE DETAILS OF HOW TO DO THIS WILL BE ON YOUR ADDRESS CONFIRMATION LETTER PROVIDED AT THE END OF THE PROCESS.
