

Right to Buy Additional Information

This form is for used by tenants who wish to claim the right to purchase their home under the Right to Buy scheme.

You could be eligible for a Right to Buy discount if:

- You are a council tenant OR you were a housing association tenant and were living in your home when it was transferred to Havering Council
- ✓ The property is your only or principle home
- You have been a public sector tenant (usually a tenant of a council or a housing association) for at least 3 years
- You don't live in sheltered housing or other housing particularly suitable for elderly or disabled people
- Your home is not due to be demolished
- ✓ You don't have any legal problems with debt
- You don't have any outstanding possession orders

If you can answer 'yes' to these statements, you are probably eligible but Havering Council will need to confirm this.

This form is used to consider your eligibility for a Right to Buy. It is used in conjunction with the RTB1 Application Form. When you have filled in both of these forms, take them or send them by recorded delivery to Havering Council

If you take them by hand, ask for a receipt. Keep a copy of the completed forms yourself.

Failure to complete this form and the RTB1 Application Form in full may delay your application from being processed.

You also understand that if you give false or misleading information or you omit information for the purpose of gaining the Right to Buy, it may be regarded as a criminal offence and action could be taken against you including court action and the recovery of property.

- 1. You may be a tenant if your name appears on the tenancy agreement, if you are unsure whether you are a tenant, you should check with Havering Council Housing Department.
- 2. You can only claim the Right to Buy if the property is your only or principal home. If you are applying to buy jointly with other tenants, all parties must complete the forms.
