# ISSUED BY: London Borough of Havering

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to the Council that there has been a breach of planning control, under Section 171A(1)(a) of the above Act, at the land described below. They consider that it is expedient to issue this Notice, having regard to the provisions of the development plan and to other material planning considerations.

# 2. THE LAND AFFECTED

The dwelling house at 30 Charlotte Gardens Romford RM5 2ED shown edged in black on the attached Plan.

### 3. THE BREACH OF PLANNING CONTROL ALLEGED

Without planning permission the sub-division of a single dwelling house into two separate flats.

# 4. REASONS FOR ISSUING THIS NOTICE

It appears to the Council that the above breach of planning control has occurred within the last four years. Planning application P0276.07, which sought permission to convert the property into two separate flats, was refused on 8<sup>th</sup> June 2007 on one of the following grounds:

(i) The proposed subdivision into 2 units and proposed internal layout is considered to give rise to noise and disturbance to future potential occupiers of the ground floor units, to the detriment of amenity and contrary to the aims and objectives of policies ENV1 and HSG7 of the Havering Unitary

Development Plan, and DC4 and DC61 of the Core Strategy and Development Plans Policy Submission Development Plan Document.

An appeal was lodged with the Secretary of State and was dismissed on 20<sup>th</sup> November 2007.

# WHAT YOU ARE REQUIRED TO DO

(i) Return the building to a single dwelling house

Time for compliance: three months from the effective date of this Notice

(ii) Remove all materials (including building materials), equipment, installations, and constructions (including internal partitions) brought onto the land in association with the unauthorised conversion

Time for compliance: three months from the effective date of this Notice

(iii) Remove all rubble, apparatus, machinery brought on to the said land arising from compliance with requirements (i) and (ii) above.

Time for compliance: three months from the effective date of this Notice

# WHEN THIS NOTICE TAKES EFFECT

This Notice takes effect on 14th July 2008, unless an appeal is made against it beforehand

The enclosed booklet "Enforcement Appeals - A guide to Procedure" sets out your rights. Read it carefully. If you appeal you should use the enclosed appeal forms. Two copies are for you to send to the Secretary of State if you decide to appeal. The other is for you to keep as a duplicate for your own records. You should also send the Secretary of State a copy of the Enforcement Notice.

### **GROUNDS OF APPEAL**

The grounds of appeal are set out in Section 174 of the Town and Country Planning Act 1990 and are also set out on page **2-5** of the enclosed appeal forms.

### PLANNING APPLICATION FEE

Should wish to appeal on ground (a) - that planning permission should be granted for the unauthorised development - then a fee of £265 is payable both to the Secretary of State and to the Council. If the fees are not paid then that ground of appeal will not be valid.

#### STATEMENT ON GROUNDS OF APPEAL

You must submit to the Secretary of State, either when giving notice of appeal or within 14 days from the date on which the Secretary of State sends him a notice so requiring him, a statement in writing specifying the grounds on which you are appealing against the enforcement notice and stating briefly the facts on which you propose to rely in support of each of those grounds.


