Claim period

A valid claim, fully supported by the evidence/documentation set out below, for the above mentioned property

must be made before:- ...6th August 2025......(15 working days from day after seizure notice)*

Documents required for a valid claim of entitlement

- 1. Proof of I.D. valid photo card driving licence or passport
- 2. Proof of address (e.g. two utility bills in the applicant's name no older than 3 months)
- 3. Vehicle Registration document for seized property (Full V5 must be provided)
- 4. Valid insurance
- 5. Written proof of authority to act as Agent IF acting in a representative capacity (e.g. valid power of attorney + items 3 4 above and proof of ID and address of **Agent**)

UNCLAIMED PROPERTY

If a seizure notice has been published and served in accordance with regulations and

- The claim period has ended and no claim was made
- A claim was made within the claim period but the seizure authority did not determine that the claimant was entitled or
- A duty to return arose but has ceased in accordance with regulations

The seizure authority may immediately dispose of seized property
