UPON the Application of the Claimant dated [x] August 2026 (the 'Application') seeking to continue to the injunction Order of Jonathan Glasson KC (sitting as a Deputy Judge of the High Court) dated 13 October 2025 for a period of one year as against the 106th Defendant (Persons Unknown) only

AND UPON the court being satisfied that the Application has been served on the 106th Defendant (Persons Unknown) in accordance with the Order dated 13 October 2025

AND UPON hearing Natalie Pratt of counsel for the Claimant [*and there being no attendance by or representations made for or on behalf of the 106th Defendant (Persons Unknown)*]

IT IS ORDERED THAT:

INJUNCTION ORDER

1. Until and including **19 October 2027**, the 106th Defendant (Persons Unknown) are **forbidden** from:
 - i. forming an **Encampment** on the **Sensitive Sites** or any part of the **Sensitive Sites** within the London Borough of Havering:
 - a. without **Written Permission from the Local Planning Authority**; or
 - b. without planning permission granted by the Secretary of State; or
 - c. not in accordance with statutory permitted development rights; or
 - d. without having secured written consent from the landowner of the relevant **Sensitive Site**, and without having given the Local Planning Authority 2 working days' written notice of the intention to stop on the site by giving notice to the Enforcement & Community Safety Team, Havering Town Hall, Main Road, Romford, RM1 3BD and legal.services@onesource.co.uk and enforcement.managers@haverling.gov.uk providing:
 - i. the dates on which those forming the **Encampment** intend to occupy the **Sensitive Site**; and
 - ii. the number of caravans and/or mobile homes and other vehicles that will be present on the **Sensitive Site**.
 - ii. stationing on the **Sensitive Sites** or any part of the **Sensitive Sites** any caravans/mobile homes other than when:
 - a. driving through the London Borough of Havering; or
 - b. in compliance with the parking orders regulating the use of car parks and parking spaces; or
 - c. with the express permission from the owner of the relevant **Sensitive Site**.
 - iii. depositing or causing to be deposited, **Controlled Waste** in or on the **Sensitive Sites** or on any part of the **Sensitive Sites**, unless a waste management licence or environmental permit is in force and the deposit is in accordance with the licence or permit.

Definitions

2. In this Order, the following definitions shall apply:
 - i. '**Sensitive Sites**' means all the sites within the London Borough of Havering as marked on the map at Schedule 2 to this Order and numbered 1 to 306 (save for site

numbers 27, 51, 88, 133, 151, 155, 268, 286, 287, 288, 289, 291, 295, 300, 301, 302 and 304).

- ii. **‘Encampment’** means the entering and/or occupying of any land or part of land for residential purposes (whether temporary or otherwise), including the occupation of caravans/mobile homes, and the storage of vehicles, caravans and residential paraphernalia.
- iii. **‘Controlled Waste’** has the same meaning as within s.75(4) of the Environmental Protection Act 1990, namely household, industrial or commercial waste or any such waste.
- iv. **‘Written Permission from the Local Planning Authority’** includes, but is not limited to, written permission granted pursuant to any negotiated stopping agreement, policy, procedure or practise.

SERVICE

- 3. Pursuant to CPR 6.15 and CPR 6.27, and for the purposes of CPR 81.4, this Order shall be deemed served on the 106th Defendant (Persons Unknown) on the date when a copy of the Order (as opposed to an original) is affixed as a laminated copy or in a transparent envelope in a prominent position on each of the Sensitive Sites.
- 4. For the avoidance of doubt, service shall be effected when a copy of the Order is first affixed in accordance with paragraph 3 above, irrespective of whether the Order is subsequently removed by a third-party.

LIBERTY TO APPLY

- 5. The Defendants or anyone notified of this Order may each of them apply to the court on 72 hours written notice to both the court and the Claimant (without prejudice to the right of that person to apply to shorten the time for written notice) to vary or discharge this Order or so much as if it affects that person. The contact details for both the court and the Claimant can be found in paragraphs 7 and 8 below.
- 6. Any person who applies to vary or discharge or discharge this Order must supply their full name and address for service.

COMMUNICATIONS WITH THE CLAIMANT AND THE COURT

- 7. All communications to the Claimant about this Order should be sent to the Enforcement & Community Safety Team, Havering Town Hall, Main Road, Romford, RM1 3BD and email addresses legal.services@onesource.co.uk and enforcement.managers@haverling.gov.uk.

REVIEW OF THIS ORDER

9. The Order against the 106th Defendant (Persons Unknown) will expire by the effluxion of time at 23:59hrs on 19 October 2027. The Claimant may, if so advised, apply for the renewal of the Order against the 106th Defendant (Persons Unknown) (the '**Renewal Application**'). Any Renewal Application and evidence in support must be filed and served by 4pm on **15 September 2027**. The Claimant shall serve the Application Notice in accordance with paragraph 3 above. All evidence in support of the Renewal Application need only be uploaded to the designated injunction webpage operated by the Claimant, provided that the Application Notice is accompanied by a notice to Persons Unknown which provides both the details of the injunction webpage and where hard copies of the supporting evidence can be obtained, if preferred.
10. A hearing shall be listed on **6 October 2027**, with a time estimate of ½ day, at which the Renewal Application shall be considered. If the Claimant does not make a Renewal Application, it must notify the court as soon as reasonably practicable and seek to vacate the hearing.
11. Any person other than the Claimant who would like to participate in the hearing of the Renewal Application must file and serve on the Claimant any evidence upon which they intend to rely at the hearing of the Renewal Application by 4pm on **22 September 2027**.

COSTS

12. No order as to costs against the 106th Defendant (Persons Unknown).

GUIDANCE NOTES

EFFECT OF THIS ORDER

1. A Defendant who is an individual who is ordered not to do something must not do it himself/herself/themselves or in any other way. He/she/they must not do it through others acting on his/her/their behalf or his/her/their instructions or with his/her/their encouragement.

2. A Defendant which is a corporation and which is ordered not to do something must not do it itself or by its directors, officers, employees or agents or in any other way.

PARTIES OTHER THAN THE CLAIMANT AND DEFENDANTS

EFFECT OF THIS ORDER

3. It is a contempt of court for any person notified of this Order knowingly to assist in or permit a breach of this Order. Any person doing so may be sent to prison, fined, or have their assets seized.

INTERPRETATION OF THIS ORDER

4. In this Order, where there is more than one Defendant, unless otherwise stated, references to “the Defendants” means each or all of them.
5. A requirement to serve on “the Defendants” means on each of them, unless an Order of the Court specifies otherwise. The Order is, however, effective against any Defendant on whom it is served.
